#### **President-Elect:**

**Ceyhun Ozgur,** CPIM is a Professor of Information and Decision Sciences in the College of Business Administration at Valparaiso University. He earned a BS in Industrial Management and a MS in Management from the University of Akron and a PhD in business administration (Operations Management/Operations Research) from Kent State University. Among others, Dr. Ozgur has published in *Decision Sciences Journal of Innovative Education, Interfaces, OMEGA, Quality Management Journal, Mid-American Journal of Business, Production Planning and Control, International Journal of Operations and Quantitative Management, International Journal of Quality and Reliability Management, International Journal of Business Disciplines, Industrial Mathematics, Bogazici Journal and Teaching Statistics.* 

Dr. Ozgur written 10 "study guides, testbanks and instructor's manuals" for business statistics, operations management and management science textbooks including an introductory textbook with William Stevenson from Rochester Institute Technology entitled *Introduction to Management Science with Spreadsheets* for McGraw-Hill publishing company. He has presented over 30 papers at national and regional meetings. 16 of these papers have been published in conference proceedings. He is a member of the Decision Sciences Institute, and APICS and serves as a member of the editorial review board for *Decision Sciences Journal of Innovative Education* and *International Journal of Operations and Quantitative Management*. He has served as Midwest DSI VP for Planning and Development and Treasurer.

#### Secretary:

**Kristina Setzekorn** currently is the Director of both the Internship Program and Global Assistance Program at the University of Evansville's School of Business Administration. Her primary research interests deal with information technology's performance impacts. Her research has been published in the *Information Research Management Journal, International Journal on Media Management, Journal of Small Business Strategy* and *Communications of the IIMA*, and in four book chapters published by Idea Group. She has presented papers at the International Conference on Information Systems, Decision Sciences Institute Annual Conference, Americas Conference of Information Systems, the International Information Management Association Annual Meeting, the Strategic Management Society Annual International Conference, the ATiB Fall Research Seminar Series and the Mid-West Decision Sciences Institute Meeting.

She's a member of the Editorial Review Board of the International Journal of E-Business Research, 2004-2006; an ad hoc reviewer for the Editorial Review Board of the Information Resources Management Journal (IRMJ), 2004-2006 and an Associate Editor of IS World's Strategic Information Systems page. Additionally, she has served as a reviewer for ICIS, DSI, MWDSI, AMCIS, IRMJ, JSIS, Database, JCIS and Minnesota KM Symposium. She has served as the VP of Member Services for Midwest DSI.

#### V.P. Planning and Development:

**Arvid C. Johnson** is a Professor of Management at Dominican University's School of Business in River Forest, IL. Prior to joining Dominican as an Associate Professor of Management in September 2001, he was a principal in a management consulting firm and worked with companies ranging in size from startups to multi-million dollar business units of Fortune 500 companies to describe, account for, explain, and exploit the variability present in their manufacturing and service processes. Arvid also has over 15 years of engineering, manufacturing, and management experience in a variety of business environments-including Northrop Grumman Corporation, Microwave laboratories, and Varian Associates. He presently serves as the chair of Information Resources, Inc.'s Analytics Advisory Board.

Arvid has published and spoken extensively in the areas of quantitative analysis and pedagogy, microwave materials processing and electron devices, and advanced manufacturing practices and holds several US and foreign patents. He is a member of INFORMS, the Decision Sciences Institute (Information Technology Committee member), POMS, the IEEE, and the American Physical Society. His teaching experience

before Dominican includes over 6 years with Keller Graduate School of Management where he was a Senior Faculty Member.

Arvid holds a PhD in Management Science (Operations Management concentration) from the Illinois Institute of Technology in Chicago, IL; an MBA from the University of North Carolina at Chapel Hill; an MS in electrical engineering from Northeastern University in Boston, MA; and a BS in physics from Lewis University in Romeville, IL.

#### V. P. Publications:

**Xiaodong Deng**, Ph.D., is an Associate Professor of Management Information Systems at Oakland University. He has served as reviewer, discussant, session chair, and track chair at previous Midwest DSI and as reviewer, session facilitator at previous national DSI Annual Meetings. Dr. Deng has also served as the review coordinator for the 26<sup>th</sup> International Conference on Information Systems (ICIS) in 2005. His scholarly work has been published in *Decision Sciences, Journal of Management Information Systems, Information & Management, Information Resources Management Journal, Behavior and Information Technology, and Journal of Intelligent Manufacturing*. He holds a Ph.D. in manufacturing management and engineering from the University of Toledo.

#### V. P. Student Liaison:

**Tobias Schoenherr** is an Assistant Professor of Operations and Supply Chain Management at Eastern Michigan University. He received a Diplom-Betriebswirt (FH) from the European School of Business, Germany, a B.Sc. in Business Administration from Indiana University, as well as an M.B. and Ph.D. in Decision Sciences and Operations Management from Indiana Dr. Schoenherr's research interests include e-procurement, supply chain University. management, global manufacturing, and ERP systems. His work has appeared or is forthcoming in the International Journal of Operations and Production Management, the Journal of Supply Chain Management, OMEGA, Business Horizons, the International Journal of Integrated Supply Management, the Journal of Information Technology and Information Management, and PRACTIX, among others. Dr. Schoenherr is on the editorial board of the International Journal of Integrated Supply Management, and serves as an ad-hoc reviewer for several journals, including Decision Sciences, Production and Operations Management, and the Journal of Operations Besides teaching at Eastern Michigan University, he has taught at Indiana Management. University, the International Graduate School of Business in Zagreb, Croatia, the Central European University in Budapest, Hungary, and Charles University in Prague, Czech Republic.

Dr. Schoenherr has won several research and teaching awards, including the Best Student Paper Award from the MWDSI's 2002 Annual Meeting. He has served as session chair, presenter, discussant and paper reviewer for both regional and national DSI meetings he has also been a member of the Stan Hardy Best Paper Award Committee. In 2006 he took on the office of Student Liaison, and organized the Doctoral Student Consortium, as well as a Doctoral Student Research Incubator at MWDSI 2006 in Indianapolis. For the 2007 MWDSI Meeting he serves as the Track Chair for Operations and Supply Chain Management, and coordinates the Doctoral Student Consortium.

#### V.P. Member Services:

**Peter B. Southard** is an Assistant Professor of Management at the Sam & Irene Black School of Business, The Pennsylvania State University Erie, The Behrend Collage. He grew up on a farm in central Iowa, received his Bachelor of Science degree from Iowa State University, Ames, IA, and his MBA from Drake University in Des Moines, IA. He received his Ph.D. from the University of Nebraska in Lincoln where his major area was Operations and Supply Chain Management with a strong minor in Management Information Systems.

Peter has taught supply chain management, operations management, operations planning and control systems, information systems, business strategy, and statistics for over eight years on both the graduate and undergraduate level. He has published scholarly articles in journals such as *Communications of the ACM*, *The International Journal of Operations and Production Management, Benchmarking: An International Journal, Management Decision*, and *The International Journal of Healthcare Technology and Management* as well as several conference proceedings including at the annual national meetings of *Academy of Management, Decision.* His research interests include the effects of technology innovation on supply chains with a special focus on services.

#### V. P. Industry Liaison:

**Hokey Min** is the holder of James R. Good Chair in Global Supply Chain Strategy at the Bowling Green State University. He was Professor of Supply Chain Management, Distinguished University Scholar and Director of the UPS Center for World-wide Supply Chain Management, the Center for Supply Chain Workforce Development, and the Founding Executive Director of the Logistics and Distribution Institute (LoDI) at the University of Louisville. As Director, he brought more than \$6 million grants (both private and federal), endowments and gifts to the University of Louisville. He earned his Ph.D. degree in Management Sciences and Logistics from the Ohio State University. His research interests include global logistics strategy, e-synchronized supply chain, benchmarking, and supply chain modeling. He has published more than 100 articles in various refereed journals including *European Journal of Operational Research, Journal of Business Logistics, Journal of the Operational Research Society, Transportation Journal*, and *Transportation Research*.

He is currently serving on the editorial review boards for *International Journal of Integrated Supply Management* and *International Journal of Logistics: Research and Applications*. Also, he has been serving as the Regional Vice President (Industry Liaison) of the Midwest Decision

Sciences Institute (MWDSI). Over the last few years, he has been heavily engaged in various consulting and outreach efforts dealing with practical problems encountered by organizations including UPS Air, UPS Supply Chain Solutions, Dixie Warehouse Services, Pegasus Transportation, Tyme-It Transportation, Usher Transportation, National Tobacco Company, Syntel, Revere Group, Scan Steel, World Health Organization (WHO), and Brown-Forman.

#### Archivist:

**Charles A. Watts,** CPIM, Jonah, is a Professor of Operations Management in the Department of Management, Marketing, and Logistics. He received his BSBA and MBA from Bowling Green State University and his DBA from Indiana University. He has published research that appeared in *Journal of Operations Management, Journal of Supply Chain Management, Production and Operations Management, Science, Production and Inventory Management, International Journal of Operations and Production Management, International Journal of Production Research, and Operations Management Review.* 

He conducts research and consults in the areas of supplier development, purchasing and materials management, supply chain management, warehouse location and rationalization, scheduling in service and manufacturing organizations and the Theory of Constraints. He has given seminars on Information Technology in Purchasing, Basic Purchasing Training, Purchasing and Contracting, Advanced Purchasing and Contracting, Purchasing Certification, Supplier Development, Customer Focus, Project Management, Theory of Constraints, and Total Quality Management, for major corporations such as Lincoln Electric, Dana, Samsung, Lucas Industries, and Marathon Oil. He is currently a Vice-President for the Decision Science Institute, archivist for the Midwest Region of the Decision Science Institute and Executive Director of Education and Certification for the International Supply Chain Education Alliance (ISCEA). He is also a principal and Chief Science Officer with On-Point Group Consulting.

Dr. Watts was the 2004 program chair for Midwest Decision Sciences Institute and a past President. He was President of the Toledo American Production and Inventory Control Society (APICS) Chapter and served for several years on the national steering committee for the Small Manufacturing Specific Industry Group within APICS.



Under Midwest DSI's current bylaws, the term of office is one (1) year for the positions of Vice President for Planning and Development, Vice President for Publications, and Vice President for Member Services. Participants in the Midwest Strategic Planning Meeting, held in San Antonio on November 20, 2006, agreed that continuity and effectiveness in these positions would be better served if the terms were extended to two (2) years. It was further agreed that the two-year terms of office for these positions should be staggered. Consequently, the Midwest DSI membership will be asked to vote at the 2007 Annual Meeting in Chicago (April 12-14, 2007) on a bylaw revision that will establish two-year terms for these positions according to the following schedule:

# MIDWEST DSI OFFICERS MEETING MINUTES

Sunday, November 19, 2006 San Antonio, TX

Present: Carl Briggs, Ed Duplaga, Xiaodong Deng, Jan Hartley, Chang Liu, Anne Koehler, Rhonda Lummus, Ceyhun Ozgur, Diane Parente, Dick Penlesky, Charles Petersen, Tobias Schoenherr, Kristina Setzekorn, Bill Tallon

The meeting was called to order by Dick Penlesky at 3:00 p.m.

- 1. Bill Tallon moved to approve the minutes of March 25, 2006. The motion was seconded by Carl Briggs. The minutes were approved.
- 2. Annual Meeting Reports:
  - a. 2006, Indianapolis, IN: Carl Briggs, Program Chair, had nothing new to add beyond the report given in the last MWDSI Newsletter (i.e., Volume 19, Number 2, Fall 2006). On behalf of the Region, Dick Penlesky thanked Carl for his service as program chair.
  - b. 2007, Chicago, IL: Charles Petersen, Program Chair, reported that the hotel for the conference is set—Hilton Garden Inn. Conference flyers were available at the registration table at the current San Antonio meeting. Charles is working on lining up track chairs. If any BOD members know anyone who might be interested in participating, let Charles know. The plant tour is also being worked on.
  - c. 2008, Erie, PA: Diane Parente, Program Chair, reported on some of the preparation work that is occurring. Several ideas for plant tours have already been identified. Diane has also been investigating possible hotels for the meeting and has a possible speaker.
- 3. Officer Reports:
  - a. President-Elect: Charles Petersen raised the question that since the MWDSI reception at the national meeting has been discontinued, can we still solicit funds from schools (in particular those schools that have contributed to the reception in the past) to be used at the MWDSI annual meetings? Some BOD members thought that it was a good idea, but we would have to know and state specifically how the funds would be used.
  - b. Secretary: Ed Duplaga had nothing to report.

- c. Treasurer: Chang Liu presented the balance sheet for FY 2005-06 and the FY 2006-07 budget worksheet. A projected expense of \$800 for insurance needs to be added to the 06-07 budget worksheet.
- d. Planning and Development:
  - i. 2009 meeting: Rhonda Lummus reported that Iowa State is not interested in sponsoring the meeting in an out-of-state location. They are willing to sponsor the meeting if it is held in Des Moines, IA. No certain program chair is identified at this time.
  - ii. 2010 meeting and future meetings: Carl Briggs reported on an analysis of current MWDSI membership (see attached). Based on the analysis, Carl made a motion concerning the locations for future MWDSI meetings (see attached). Kris Setzekorn seconded the motion. Carl then made a motion to table the discussion so that BOD members will have time to think about the proposal in order to allow a more complete discussion. Jan Hartley seconded the motion, and the motion passed.
- e. Membership Services: Kris Setzekorn had nothing to report.
- f. Industry Liaison: No report from Hokey Min. Jan Hartley suggested that Charles Petersen get Hokey Min involved in the Chicago meeting.
- g. Student Liaison: Tobias Schoenherr had nothing new to add beyond the report given in the last MWDSI Newsletter. Diane Parente suggested that a session on development of a research strategy be included in the MWDSI doctoral consortium.
- h. Publications: Xiaodong Deng thanked the contributors for their contributions to the last newsletter.
- i. Archivist: Dick Penlesky mentioned for Charles Watts that it is important to keep the website for MWDSI annual meetings active for at least a year after the meeting.
- j. Regional VP: Bill Tallon reported that there are 1199 attendees at the San Antonio meeting. This year's meeting included four full days of sessions. Bill also mentioned that globalization of DSI appears to be one of the primary issues being addressed by the National BOD.
- k. Fellows Committee: Dick Penlesky reported that Bill Perkins and Anne Koehler have both agreed to serve on the MWDSI Fellows Committee. Chan Hahn still needs to be contacted. Jan Hartley made the motion that this year's Fellows Committee be comprised of Anne Koehler, Bill Perkins, Chan Hahn, Dick

Penlesky, Jan Hartley, Charles Petersen and Ed Duplaga. Ceyhun Ozgur seconded the motion, and the motion was approved.

- 4. Nominating Committee: Charles Petersen made a motion nominating Kris Setzekorn to serve on the Nominating Committee. Xiaodong Deng seconded the motion, and the motion passed. Diane Parente made a motion to approve the membership of the Nominating Committee: Jan Hartley (chair), Dick Penlesky, Charles Petersen and Kris Setzekorn. Carl Briggs seconded the motion, and the motion passed.
- 5. Stan Hardy Award: Dick Penlesky thanked the members of last year's committee.
- 6. MWDSI Reception at 2007 National Meeting: Dick Penlesky suggested that the discussion be postponed until tomorrow's strategic planning meeting.

Diane Parente moved to adjourn the meeting at 4:31 p.m. The motion was seconded by Ceyhun Ozgur and approved.

#### **Program Planning and Development Report**

Carl M. Briggs Midwest Decision Sciences Institute Business Meeting, 11/19/2006

Report:

As a result of planning for the MWDSI 2006 annual meetings, I did some analysis of current MWDSI membership. Here's what an analysis of the 2005-2006 MWDSI and national DSI databases reveal:

- According to national DSI records, there are approximately 150 people who are affiliated with a school in the Midwest region who are NOT members of MWDSI. This group represents a potential increase of 25% to current DSI membership. This group should be targeted for membership.
- There were 545 people in the 2005-2006 MWDSI email distribution list. Of that number approximately 7% had email addresses that indicated they were corporate members or the email address could not be connected with a particular school.
- The remaining members had affiliations with 172 academic institutions. Of these institutions,
  - 19% were from outside the Midwest region (identified broadly as the following states: Illinois, Indiana, Iowa, Kansas, Kentucky, Michigan, Minnesota, Missouri, Nebraska, North Dakota, Ohio, South Dakota, and Wisconsin).

- The majority of the members "outside" the Midwest come from the south (approximately half) and then the west, and then the east.
- Of Midwestern states, the membership breakdown is as follows:
  - 21% Ohio
  - 13% Indiana
  - 12% Michigan
  - 09% Illinois
  - 06% Minnesota
  - 04% Wisconsin
  - 03% Iowa
  - 03% Nebraska
  - 02% South Dakota
  - 02% Missouri
  - 02% Kansas
  - 01% North Dakota
  - 01% Kentucky
- While these numbers are influenced by the location of the most recent MWDSI meetings, and do not reflect actual population distribution or the potential pool of members, it does seem to indicate that there is a "Core" group of states where participation in MWDSI is strong (Ohio, Indiana, Michigan, and Illinois), and a "Growth" group of states where participation is measurably lower (Minnesota, Wisconsin, Iowa, Nebraska, South Dakota, Missouri, Kansas, North Dakota and Kentucky). Identifying the "Core" and the "Growth" groups is an important component of strategic planning for future program locations and program development in general.

**<u>Proposal for Annual Meeting Site Rotation</u>**: This motion will be presented in five parts (to facilitate discussion of each element) and upon a second, will be tabled for future discussion (in order to allow complete discussion).

Whereas a long-term rotational plan for annual meeting locations would allow MWDSI to significantly improve long-term planning for meetings, and

Whereas a long-term rotational plan for annual meeting locations would allow MWDSI to leverage its spend on the annual meeting, opening the possibility of long-term contracts with certain vendors, and

Whereas a long-term rotation plan would allow for better long-term planning,

- A. A motion is made to develop a five-year rotational plan for the location of the Midwest Decision Sciences annual meeting. Location selection would focus on strengthening membership participation in "Core" states (Ohio, Indiana, Michigan, and Illinois) in years 1, 3, and 4 of the cycle, and on "Growth" areas (non core states in the Midwest and beyond) in years 2 and 5 of the cycle
- B. At least one of the "Growth" years should be held at a high-profile resort location, not necessarily in the region.

- C. Site location decisions, especially for years 2 and 5 in the cycle should be made with sensitivity to travel costs.
- D. Specific site location decision should be made in connection with specific membership growth initiatives and in coordination with MWDSI strategic plans.
- E. This site location plan would begin with the 2010 annual meetings, with two cycles identified (2010-2020) and approved at the annual meetings in Chicago, 2007.
