Keynote Speech: "Logistics of the American Circus: The Golden Age," by Vince Mabert

Competitive pressures today require enterprises to continually improve performance for various business activities, such as customer service and waste reduction. One area currently receiving significant attention is the logistics function within organizations. In the last decade, numerous authors have proposed many modern logistics management principles and practices that focus on dimensions such as lean, fast, flexible, and so on. Many of these approaches are not new, but rather have been used and refined by business organizations in earlier times. This presentation will describe many logistics methods employed by the major circuses more than a century ago. While the technology and terminology of that time were different, similarities with current management thought and practice are evident. By reviewing these logistics activities from a century ago, new ideas about logistics for tomorrow can be formulated.

Super Bowl Presentation

Indianapolis will be home to the 2011 Super Bowl at beautiful new Lucas Oil Stadium, the home of the Indianapolis Colts. A keynote speaker will describe project management and logistics issues related to this exciting event. .

Indianapolis Motor Speedway Tour and Reception

The Indianapolis Motor Speedway is the world's largest spectator sporting facility. It annually plays host to three events in three major racing series: Indianapolis 500 Mile Race (IZOD Indy-Car Series), Brickyard 400 (NASCAR Sprint Cup Series) and Red Bull Indianapolis GP (MotoGP World Championship). The Indianapolis 500 and Brickyard 400 take place on the 2.5-mile oval, while the Red Bull Indianapolis GP is contested on the 16-turn, 2.621-mile road course. Established in 1909, the Indianapolis Motor Speedway has long prevailed as an icon of motorsports excellence. The Speedway is currently celebrating its Centennial Era, commemorating the 100th anniversary of the Indianapolis 500 Mile Race in 2011. MWDSI participants will be treated to a tour of the facility, including a ride around the 2.5 mile oval track, and a reception at the track on Friday evening.

FedEx Tour: the Night Sort

Indianapolis is home to the second-largest FedEx operation in the world. The Indianapolis Airport comes alive at night when FedEx plans arrive at frequent intervals and millions of packages are sorted and routed to their destinations, supported by an operation that includes its own air traffic control operation, a highly automated sorting process and facilities for the visiting pilots. The night sort tour will include a presentation about sorting operations and tour, running from approximately 10:15 pm Thursday night until 2:00 am Friday morning.
