It is understood that submissions have not been previously published in a Proceedings or journal, nor are submissions currently under review for publication or presentation elsewhere. Submission of a paper implies that an author will register for the conference, attend the conference, and personally present the paper, if accepted. MidWest Decision Sciences Institute is pleased to launch the Project Management Program Track in partnership with the Decision Sciences Institute. In an effort to increase teaching and research interest in Project Management and further the partnership between MWDSI and its parent institution, several sessions on project management will be offered at the 2010 MWDSI Annual Meeting in Toledo. The intent is to draw from the collective membership of both organizations to establish these sessions. ### **NEW MIDWEST DSI OFFICERS NOMINATED**

The following individuals were recently nominated for vacant positions on the Executive Board of Midwest DSI.

**President-elect:** Xiaodong Deng is an Associate Professor of Management Information Systems at Oakland University. He has served as the Treasurer and VP for Publication for Midwest Decision Science Institute (DSI). He has also served as reviewer, discussant, session chair, and track chair at previous Midwest DSI and as reviewer, session facilitator at previous national DSI Annual Meetings. Dr. Deng has served as the review coordinator for the 26<sup>th</sup> International Conference on Information Systems (ICIS) in 2005 and for the doctoral consortium at 27<sup>th</sup> ICIS in 2006. His scholarly work has been published in *Decision Sciences*, *Journal of Management Information Systems*, *Information & Management, Information Resources Management Journal, Behavior and Information Technology, and Journal of Intelligent Manufacturing*. He holds a Ph.D. in manufacturing management and engineering from the University of Toledo.

Treasurer (2-year term): Hokey Min currently holds the James R. Good Chair in Global (Supply Chain) Strategy in the Department of Management at the Bowling Green State University. He was a Professor of Supply Chain Management, Distinguished University Scholar, Founding Executive Director of the Logistics and Distribution Institute (LoDI), and Founding Director of the UPS Center for World-wide Supply Chain Management and the Center for Supply Chain Workforce Development at the University of Louisville. He received an MBA (in Production Management) from Yonsei University (Seoul, Korea), M.S. in Operations Management from the University of South Carolina, and gained his PhD in Management Sciences and Logistics from the Ohio State University. His research interests include global logistics strategy, supply chain resilience, benchmarking, and supply chain modeling. He has published more than 130 articles in various refereed journals including European Journal of Operational Research, Journal of Business Logistics, Journal of the Operational Research Society, Transportation Journal and Transportation Research.

Dr. Min has been actively involved in both the regional (i.e., Midwest, Southeast, and Northeast) and national Decision Sciences Institute activities for more than two decades. He served as a session chair, presenter, discussant, and paper reviewer for both regional and national DSI meetings. He recently served as VP of Industry Liaison for the Midwest Decision Science Institute in 2007-2008 and has been serving as VP of Publications since 2009.

**VP for Publications: Peter A. Salzarulo** is an Assistant Professor of Supply Chain Management in Miami University's Farmer School of Business. He received his Ph.D. from Indiana University's Kelley School of Business with concentrations in Operations Management and Decision Sciences. His research interests include the use supply chain coordination mechanisms in manufacturing organizations, appointment scheduling, and quality management in the healthcare settings. Prior to pursuing his Ph.D., he worked for a heavy equipment manufacturer in the paper industry in field service and application engineering rolesis an Assistant Professor of Operations and Supply Chain Management at the University of Toledo. He received his B.S. in Engineering from the University of Poona, India, a M.S. in Industrial Engineering from the University of Cincinnati and his Ph.D. in Operations Management and Decision Sciences from Indiana University.

**VP for Industry Liaison: Brad Hull** is an Associate Professor of Operations Management in the Department of Management, Marketing, and Logistics at John Carroll University. He received his BS in Mathematics from the University of Pennsylvania, MS in Operations Research from Stanford University, and PhD in Operations Research from Case Western Reserve University. Dr. Bradley Hull has previously held faculty positions at Washington University, Kent State University, Case Western Reserve University and Lake Erie College. His teaching includes courses in operations management, logistics, and transportation.

In addition to his position at John Carroll University, Dr. Hull consults for the Port of Cleveland. Prior to John Carroll, Dr. Hull had an extensive career managing supply chains in the oil and chemicals industries with British Petroleum. At BP he was logistics director for BP Chemicals Company and later managed (much of) the Alaskan Oil supply chain.

He has published articles in the *International Journal of Logistics Management, International Journal of Production Economics, Journal of the Transportation Research Forum, Journal of Macromarketing*, and *Logistics Information Management*. He is a member of the CSCMP, CFA, ISM, WERC, OFCA, and, of course, DSI.

VP for Student Liaison: Sachin Modi is an Assistant Professor of Operations and Supply Chain Management at the University of Toledo. He received his B.S. in Engineering from the University of Poona, India, a M.S. in Industrial Engineering from the University of Cincinnati and his Ph.D. in Operations Management and Decision Sciences from Indiana University. Dr. Modi's research interest include procurement, supply chain management, innovation and information technology. His work has appeared in the *Journal of Operations Management*. He serves as an ad-hoc reviewer for the *Journal of Operations Management*, *Journal of Supply Chain Management*, *International Journal of Operations and Production Management*, and *Production and Inventory Management Journal*. He also served as track chair for the 2009 POMS conference and VP for Student Liaison for the Midwest DSI for the 2009-2010 year. In the past he has also served as reviewer for both the regional and national DSI meetings.
